Article 1

This Agreement is aimed to the organisation and intensification of contacts between partners in research in the field of electrotechnology and other fields of interest for both partners.

Article 2

The Agreement is aimed to carry out mutual works in the field of optimisation of complex electrotechnology systems.

Other fields of mutual interest for the partners can be included in the Agreement after the proposal of one partner and the agreement of the other.

Article 3

For the realisation of the Agreement the partners agree and develop the Program of cooperation for the subsequent year within December, 15th of the each year. The yearly Program contains the specification of the research work, responsible persons and expected basic results.

Article 4

The partners will carry out mutual researches as well as exchange of technical information in the above fields and, according to the availability of funds, will organise seminars and meetings.

Article 5

The partners agree to have the confidentiality about the Agreement, research results, information, experience, etc., if one of the partners require the confidentiality of these. Publication or information to a third partner about these results can be done only with mutual written agreement.

Article 6

According to the availability of funds and the current year Program the partners will carry out the mobility program of professors and researches for the realisation of the mutual works. Transport expenses are paid by the sending partner. Accommodation and daily allowance are paid by the receiving partner in accordance with the internal current rates at partner organisation and availability of funds. Both partners agree that this contract does not contain any financial obligations for any side, and that measures will be pursed on the conditions that national or international funds are available for the specific purpose.

Article 7

Each partner is responsible for finding its own financial support for the realisation of his own part of the research activity.

Article 8

The present Agreement is a prolongation of the Agreement from December 2009. The Agreement is valid for 1 year. It will be automatically renewed by 1 year if no one of the partners is terminated the Agreemennt.

This Agreement is drafted in English language in two (2) identical copies, each copy will be signed by the representatives of the parties and legalised with an official stamp.
